Plant Chair, Bill Panetta- Regarding line 116 and Vaqta, there were 25 jobs where the shift and job description matched. There will be 80 members that will go to unqualified jobs, Operator to Support Associate. A preference sheet will be sent out and seniority rules. There are 15 members that do not have a home. There will be no layoff this year. There is an expedited arb for representation in Health Services, the company wants to limit representation to Weingarten Rights. The Union wants to expand for anytime a member wants representation. The Plant Committee will send out a rationale of the decision of the Plant Committee.

Treasurer, Dan Peterson- There were only two new hires today. Over Thirteen retirees to leave last month. We expect a number or retirees to leave this year.

Financial Secretary, Steve Reed – Reached out to Greg Bowden for financial planning for new hires and older members. Human Resources will allow visitors on site and management will allow member to attend if they can get off the floor. He hopes we can do it this year.

The Organizing Committee is exploring ideas of bringing a food truck to plant site for union members only as a thank you because we are "Awesome".

There was a company the committee was hoping to organize but the company brought in union busters and the employees decided not to organize.
